



Mon Health Medical Center General Visitation Guidelines

- Visitation hours: 12:00P – 7:00P
- All visitors should arrive wearing a mask and continue to wear during their entire stay.
- Visitors will be screened at the entrance using CDC recommended questions.
- All visitors should apply hand sanitizer upon entry and departure from patient rooms and the facility.
- Visitors must be age 18 or older.
- Compassionate care considerations and exceptions may be made on a case-by-case basis.

***Exceptions to visitation may be made based on patient condition and will be evaluated by the House Supervisor and/or Administrator on Call.*

Adult Inpatient and Surgery/Procedural Visitation

- Adult inpatients who are admitted to a Mon Health facility may have one visitor per day during visiting hours.
- No visitors permitted for anyone in isolation for suspected or confirmed COVID-19.
- Individuals accompanying surgery patients will be directed by surgical/procedural staff regarding where to wait for updates after the procedure.
- Pediatric patients may have one visitor accompany them during their procedure.

Labor & Delivery and Mother Baby Unit Visitation

- Labor & Delivery and postpartum patients who are admitted to a Mon Health facility may have one designated support person in labor, delivery, and for the duration of the mother's hospital stay.

Emergency Department Visitation

- Emergency Department patients will be allowed one consistent visitor who will always remain masked and in the exam room. No visitors permitted for anyone in isolation for suspected or confirmed COVID-19. Failure to follow this rule will result in the visitor being asked to leave the hospital.
- All other visitors must remain in vehicles.

Outpatient Testing, Physician Offices and Clinics Visitation

- Due to limited space in waiting rooms, visitors will not be allowed to wait in the waiting areas.
- If an essential caregiver is needed for assistance, only one person may accompany the patient.

- All visitors should apply hand sanitizer upon entry and departure from patient rooms and the facility.
- Visitors must be age 18 or older.
- Compassionate care considerations and exceptions may be made on a case-by-case basis.

***Exceptions to visitation may be made based on patient condition and will be evaluated by the House Supervisor.*

Adult Inpatient and Surgery/Procedural Visitation

- Adult inpatients who are admitted to Mon Health SJMH facility may have one visitor per day.
- No visitors permitted for anyone in isolation for suspected or confirmed COVID-19.
- Individuals accompanying surgery patients will be directed by surgical/procedural staff regarding where to wait for updates after the procedure.
- Pediatric patients may have one visitor accompany them during their procedure.

Labor & Delivery and Mother Baby Unit Visitation

- Labor & Delivery and postpartum patients who are admitted to a Mon Health facility may have one designated support person in labor, delivery, and for the duration of the mother's hospital stay.

Emergency Department Visitation

- Emergency Department patients cannot have a visitor unless it is a support person and only under certain circumstances such as for a pediatric patient or as a caregiver. No visitors permitted for anyone in isolation for suspected or confirmed COVID-19. Failure to follow this rule will result in the visitor being asked to leave the hospital.
- All other visitors must remain in vehicles.

Other Department and Clinics Visitation

- No visitors, unless requested by a physician, in the Infusion/Vein Center.
- No visitors unless a patient needs a caregiver or is a pediatric patient in the Laboratory, Radiology, Respiratory, EKG, Sleep Lab, Cardiac Rehab, or Physical Therapy Departments.
- Ultrasound allows one visitor who is the same person through the entire procedure.

Outpatient Testing, Physician Offices and Clinics Visitation

- Due to limited space in waiting rooms, visitors will not be allowed to wait in the waiting areas.
- If an essential caregiver is needed for assistance, only one person may accompany the patient.
